Payouts will be determined on the number of boats participating at each event.

RELEASE WAIVER

I have completed this application and have submitted the total entry fee for participation in these tournaments. In consideration of the privilege of participation in this tournament, I by my signature below hereby waive and release The Bass Federation of Oregon, TBF, FLW Outdoors and tournament officials and all sponsoring organizations from all claims for injury and/or damage incurred in connection with this event. I understand and acknowledge that fishing is a dangerous sport, the risk of which include through not exclusively, drowning, collisions in the water and injuries from hooks and other fishing paraphernalia. I voluntarily assume responsibility for these risks, identified and not identified, and all risk of injury or death or damage to my property or myself or to others, including spectators and their property, arising from my participation in the tournament. I agree that tournament hosts shall have the right to take photographs or recording of myself and to use or dispose of such material in any lawful manner. I understand that entry fees are non-refundable and non-transferable. I, the boater, further certify that I have \$300,000.00 of boating liability insurance providing coverage for personal injury and property damage that might occur on my behalf. I have sufficient health, accident and liability insurance to cover any bodily injury or property damage incurred by myself or others as a result of my participation in this event. I have no past or present medical or psychological condition that might affect my participation in the tournament in such a way as to cause harm to myself or to others.
